INTEREST RATES and INTEREST CHARGES:	
Annual Percentage Rate (APR) for Purchases and Cash Advances	<b>13.65 % - 18.00 %</b> depending on your credit history. This APR will vary with the market based on the Prime Rate.
APR for Balance Transfers*	<b>9.49 % - 15.49 %</b> Introductory APR until the balance transfer is paid in full for balances transferred within 90 days of account opening. All other balance transfers, purchases and cash advances will be at the Standard APR of <b>13.65 % - 18.00 %</b> depending on your credit history. The Standard APR will vary with the market based on the Prime Rate.
Paying Interest	Your due date is at least 21 days after we mail your billing statement. We will not charge you interest on purchases if you pay your entire new balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the date the cash advance or balance transfer is posted to your account.
Minimum Interest Charge	If you are charged interest, the charge will be no less than \$0.50.
